IN SEARCH OF A MONEY TREE

The year is 1985. Bayswater Bowls Club has just received a planning permit allowing it to build the club. But it is virtually broke. Most of its funds had been chewed up fighting its case at the Planning Appeal Tribunal.

So how did we raise money? Raffles, car rallies, Tupperware parties, cinema outings, garage sales. Although there's no record of us ever having run a chook raffle, the chances are we did that too.

Here's some of the activities we undertook, beginning with a dinner dance (chicken supper) at the Fibremakers Social Club in Canterbury Road, at a cost of \$15 per double or \$8 per single, with drinks available at bar prices. At that time, Fibremakers was a huge company, part of the ICI group that had started life as British Nylon Spinners, and in the tradition of big UK companies of the time, it had a large social club for its employees with facilities that included a full bar, a large hall, a bowling green (where we would play in social games) and soccer pitches.

An outing to the Waverley Cinema to see "Indiana Jones and the Temple of Doom" cost members and friends \$10 which included supper after the show. It made a \$70 profit. A pokie trip to Laverton including morning tea, lunch and a hot snack before leaving on the return journey was priced at \$12.50. We were sternly warned, though, that "due to Transport Regulations no alcohol is allowed to be consumed on the bus."

We had tickets to the Moscow Circus on Ice, and we contemplated a weekend in Sydney to see "the smash hit musical of the decade," Cats. There was a Casserole and Games night at the home of Ray and Rita Adkins; a cake and jam stall at an Apex Carnival in Bayswater. We took over a Chinese restaurant for a banquet meal and boasted "if we could always Page 4—BBC News, May 2024

problems would be over." Which was something of an exaggeration. But it was a successful night. Not everything we did was conventional. We invented Bowlotto, which was to run for more than 30 years, at the unchanged price of \$1 a week! We worked in conjunction with Bayswater Lions to deliver Yellow Pages telephone directories, a venture that made \$300 for the club.

Meg Stent opened up her home for a display of needlework, crochet, lace, patchwork and quilting, items that were the handiwork of her late mother, Mrs Ivy B. Rich of Bayswater. Many of the these had won prizes at the Royal show. Included in the display was a quilt which won the Florence Monad trophy for the best piece of craftwork in the Royal Show and also a quilt more than 50 years old that the late Queen Mary wanted to buy. Some pieces were more than 70 years old. Meg charged \$2 admission and threw in afternoon tea.

And so it went on. In one month (July, 1985) we banked \$2000., which sounded pretty good until you realised that somehow we had to find \$300,000 to \$350,000 for the project.

The answer took a lot of lobbying, but came by way of a \$50,000 grant and \$50,000 interest free loan from Knox Council and the formation of a Co-operative which was able to borrow \$120,000. That loan had to be guaranteed by the Treasurer of Victoria, at that time Rob Jolly, ironically the man who oversaw the sale of the State Bank and the collapse of the Pyramid Building Society.

(To put this in perspective, \$1 in 1985 is worth \$3 today ... so the club was looking at finding the best part of a million dollars.)

HAPPY HOUR & MEMBERS DRAW

This has proved a great success with numbers growing all the time.




but we are fortunate that to date we are on schedule.

INITIATIVES

It is very important for a club like ours with our Constitution and By-Laws that we continue to act responsibly. I can report that the Board has met regularly during the year with a 95% overall attendance record which is a credit to all and sundry. As a Board we also introduced a system of flying minutes-this is a meeting outside a normal face to face meeting that is facilitated to address pressing matters rather than waiting for the next formal meeting. A flying minute contains a motion which is sent out via email with all Board members given the opportunity to vote. The motion is either accepted or declined and acted upon if required immediately, with such decision being ratified at the next formal meeting. This has enabled our Board to act efficiently and promptly on many varied matters-it has proved very successful.

As you are all aware we are currently updating/renovating the Ladies amenities area. This is the result of a successful grant application courtesy Mary Doyle our Federal MP along with a successful insurance claim after a long and complicated battle which saw several initial declines overruled by the Financial Ombudsman AFCA. This is by no means a small project so unfortunately with this comes some inconvenience, however, is one that will see the Ladies area move into the coming decades with modern and much needed upgraded facilities. We thank all the Ladies for their patience during these upgrades.

still awaiting our hearing at VCAT for the recovery of our gate monies. My latest information was that it will be another 6 months before we get to court-let's hope the wait will be worth it. On a brighter note, we are in the early stages of negotiations surrounding an Earthquake Insurance Claim which could see us in a position to flush out the drains in and around both greens at the expense of our Insurer – a job that is becoming critical for the upkeep of the greens. We are in a positive position at this stage of our negotiations and once again the Board will keep you postedirrespective of the outcome our green drainage has reached a point in time where maintenance is required. In regards to the new surface on green #2, I can announce that with the excellent work undertaken by a working party headed up by John Rouse we successfully submitted a proposal to Knox City Council which they were very impressed with. We have been informed unofficially that funds for such replacement will be included in their 2025 budget. On the matter of the scoreboards, it has been highlighted as top priority at the New Boards Meeting #1 which is mooted for this coming Tuesday. There is a plan in place that will be discussed and most likely implemented at that meeting. Our priority is to have all scoreboards working ready for pennant if not just before. Finally, with the help of Jackson Taylor we have lodged an application to change the lights on green #1 to LED and to install new Lights on green #2. The total cost of this project is \$142,000.00 and is currently in the hands of Jackson who has pushed our barrow. We expect a result one way or the other very soon and will keep you posted. **OTHER CLUBS**

Treasurers Report 2024

Before I start the Report, I would just like to explain the initiatives that the Board took this financial year. Firstly, we installed a new accountancy package called XERO which you will see from the financial statements, is a far more user friendly document to read. We then linked Xero to our bank— Bendigo Bank with what is called Bank Feeds which sends information from all our accounts to Xero on a daily basis. We then purchased a new Smart Till and associated software that also communicates with Xero. All of this Software now undertakes real time balances, real time stocktakes and real time BAS analysis with the ATO. All of the above is unforgiving - meaning everything must balance or it freezes, leading to a complete overview of our clubs finances at any point in time. Also linked to the above are expenses claim capabilities for those Members who purchase items for the club on a regular basis. Xero, the till and expenses can also be accessed on Smart Phone Apps, which further streamlines the accountancy process. I would like to thank Carloine Meredith and Frances for undertaking training on this system which in turn has enabled them to upload invoices both payable and receivable as needed. Karen also uses it to send quotes for functions that are accepted by the client, then automatically converted to an invoice which ensures all monies owing are documented. Although all of this may seem daunting it has reduced workload and has reduced the need to keep cumbersome books. For any further details of our new system please feel free to reach out to me as needed.

I am pleased to announce that as of the 31st March 2024 the club had an operating profit (cash based of) **\$68,736.85**. Copies are available. A positive turnaround of \$97,251.67 due in part to sponsorship, grants, functions, tournaments, raffles and chocolates. Also due in part to a streamlining of services that were somewhat superfluous

Cash at bank \$235,646.29. See Balance Sheet for more detail. Up \$71,369.29- also due in part to sponsorship, grants, functions, tournaments, raffles and chocolates. Also due in part to a streamlining of services that somewhat superfluous were Equity \$476,442.30. See balance sheet for more detail At this point in time, we also had no liabilities – in fact we were owed \$1,542.91 see balance sheet for more detail. The transition from the old System Reckon to the new Xero required some manual journal entries that are reflected in the Balance Sheet. It was for this reason there was no comparison between this year and last year as the chart of accounts or line items did not exactly match, noting however that all bottom lines are accurate. From 2025 however, a year by year analysis will be detailed. With the Clubs age we are bound to have some expenses over the coming years in regards to maintenace as well as a cost for the mooted green replacement so it is important that we continue to be prudent in our approach to monies. We are also experiencing rising costs to run the cub like insurance, gas, water and electricity. We as a Board are very mindful of the financial pressures on households these days and as such we will strive to keep prices and fee rises to a minimum. With the club finances being in a good strong position I now ask that this report be taken as read be accepted in full.
